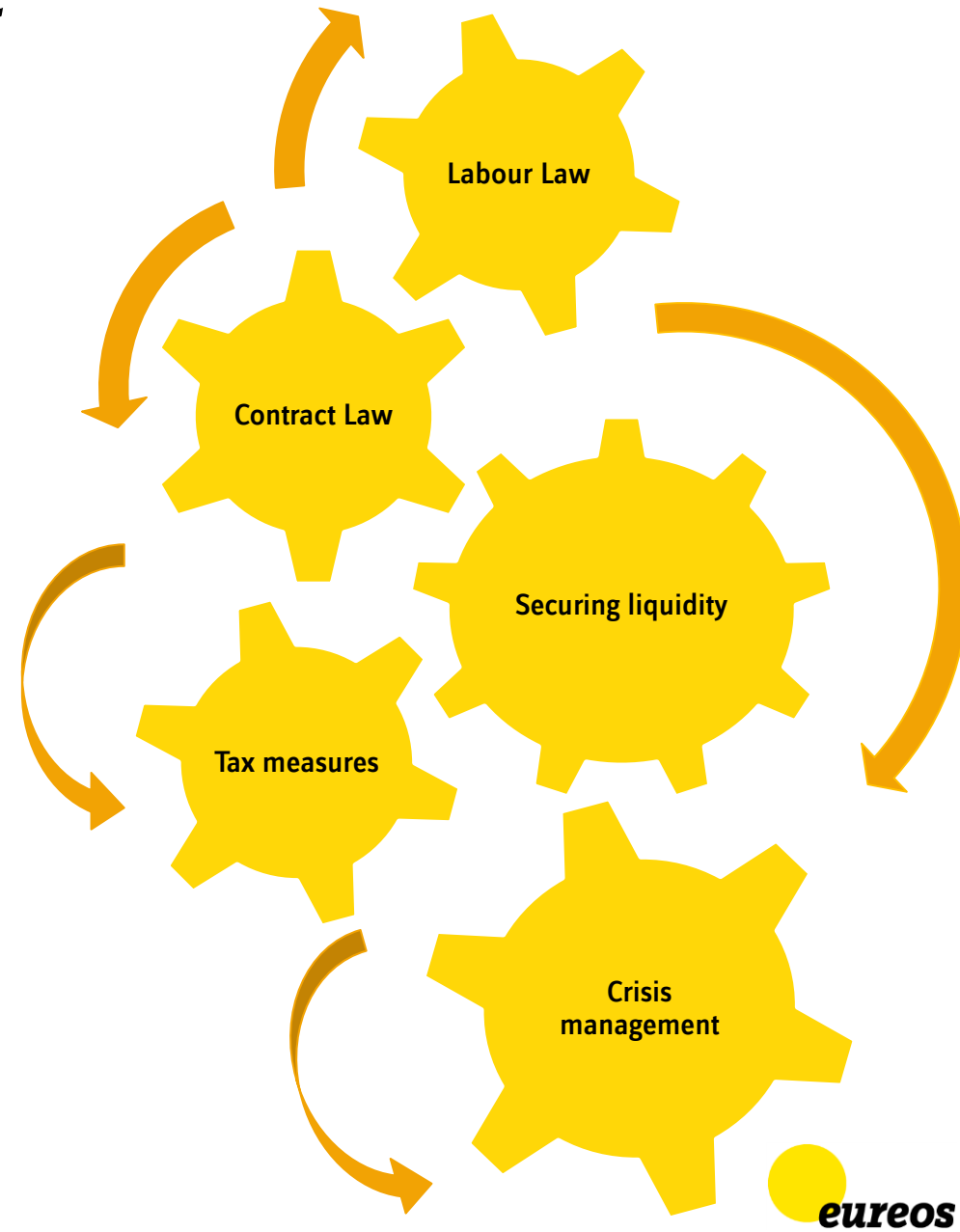

Suspension of obligations to file for insolvency

Suspension of obligations to file for insolvency

The Federal Cabinet has adopted the draft of the COVID-19 Insolvency Suspension Act. According to it, the obligation to file for insolvency will be suspended for companies that have fallen into crisis after March 1, 2020. Reorganisation measures will be privileged. In order to be able to act with legal certainty as a managing director or creditor, business and legal aspects must be assessed by an expert third party.
